Dear Sir,

Kami merujuk pada surat keterbukaan informasi Perseroan No. 198/JAPFA-OJK/LD-CS/XI/2016 tanggal 13 Oktober 2016 terkait dengan Putusan Komisi Pengawas Persaingan Usaha ("KPPU") Perkara Nomor 02/KPPU-I/2016, atas dugaan pelanggaran kartel pasal 11 Undang-Undang No. 5 tahun 1999 tentang larangan praktek monopoli dan persaingan usaha tidak sehat terhadap Perseroan dan pelaku usaha lainnya.

We refer to the announcement letter No. 198/JAPFA-OJK/LD-CS/XI/2016 dated 13 October 2016 related to the Decision of the Commission for the Supervision of Business Competition ("KPPU") on Case Number 02/KPPU-I/2016, in respect of the allegation of cartel violation of article 11 of Law No. 5 of 1999 on the prohibition of monopolistic practices and unfair business competition by the Company and other companies.

Dengan ini kami informasikan bahwa pada hari ini, Pengadilan Negeri Jakarta Barat telah memberikan putusan atas keberatan Perseroan terhadap putusan KPPU diatas.

We hereby inform that on this day, the West Jakarta District Court has issued a verdict on the objection of the Company against the abovementioned KPPU's decision.

Dalam putusannya, Pengadilan Negeri Jakarta Barat memutuskan antara lain:

In its verdict, the West Jakarta District Court ruled the followings:

1. Menerima permohonan keberatan dari 11 perusahaan yang mengajukan keberatan termasuk Perseroan;
2. Membatalkan putusan KPPU Nomor 02/KPPU-I/2016 tertanggal 13 Oktober 2016; dan
3. Menyatakan seluruh pemohon keberatan tidak terbukti melanggar tindakan kartel yang diatur dalam pasal 11 Undang-Undang No. 5 tahun 1999 tentang larangan praktek monopoli dan persaingan usaha tidak sehat.

1. Accept the appeal of 11 appellants (companies) including the Company;
2. Revoke the KPPU's verdict Number 02/KPPU-I/2016 dated 13 October 2016; and
3. Declare that all appellants are not proven to be in violation of cartel act as regulated in article 11 of Law No. 5 of 1999 on the prohibition of monopolistic practices and unfair business competition.
